COMMENT DEADLINES FURTHER EXTENDED IN SPECIAL ACCESS PROCEEDING

WC Docket No. 05-25; RM-10593

New Comment Date: July 1, 2015

New Reply Comment Date: July 22, 2015

The Wireline Competition Bureau (Bureau) hereby extends the deadlines for interested parties to file comments and reply comments in response to Section IV.B of the *Special Access FNPRM* in the Commission's special access rulemaking proceeding.¹ Comments are now due by July 1, 2015. Reply comments are due by July 22, 2015.

On December 11, 2012, the Commission adopted an order requiring providers and purchasers of special access and certain entities providing "best efforts" service to submit data and information for a comprehensive evaluation of the special access market.² In Section IV.B of the *Special Access FNPRM* accompanying that order, the Commission sought comment on possible changes to its rules for the special access services provided by incumbent local exchange carriers in price cap areas.³ The Commission set the comment deadlines on this portion of the *Special Access FNPRM* several months ahead of its release date to give interested parties an opportunity to review the information collected before filing comments.⁴

The final deadline for responding to the data collection was February 27, 2015.⁵ The Bureau is in the process of facilitating public access to the collected data consistent with the restrictions contained in

the protective order released on October 1, 2014, but has not yet made the data available.⁶ Accordingly, there is insufficient time for the public to access and review this information before filing comments and reply comments under the current deadlines, April 6, 2015 and May 18, 2015, respectively.⁷ The Bureau therefore extends the deadlines for filing comments and reply comments.⁸ Comments are now due by July 1, 2015, and reply comments are due by July 22, 2015.
