On September 8, 2016, the Satellite Division granted, subject to conditions, the application of DISH Operating L.L.C. to operate EchoStar 18 at the 61.35° W.L. orbital location instead of the initially authorized 109.9° W.L. orbital location. EchoStar 18 will operate as an in-orbit spare and use the following frequencies for telemetry, tracking, and command: 12.695 GHz, 12.696 GHz, 12.203 GHz, and 12.204 GHz (space-to-Earth); and 17.303 GHz (Earth-to-space). Command operations may also be conducted in the 17.791-17.796 GHz (Earth-to-space) frequency band.
