## WIRELESS TELECOMMUNICATIONS BUREAU RELEASES BROADCAST INCENTIVE AUCTION FILE FORMATS FOR FORWARD AUCTION ASSIGNMENT PHASE

- 1. The Wireless Telecommunications Bureau today releases specifications for Auction System data file formats for the assignment phase of the broadcast incentive auction's forward auction (Auction 1002). The Commission has determined that qualified bidders in the forward auction will have access to detailed information related to the results of bidding, and the specifications set forth the file formats in which this information will be made available to qualified bidders. We release specifications for Auction System file formats now in order to enable prospective forward auction bidders to continue familiarizing themselves with the auction process.<sup>1</sup>
- 2. The specifications and sample data files are provided on the Auction 1002 website (<a href="www.fcc.gov/auctions/1002">www.fcc.gov/auctions/1002</a>) in the Data section. The specifications provide, for each data file, an overall description of the file, the data fields that are included (with definitions of the data elements in each field), the data type, examples, and notes. Please note that for the sample data files the website provides a single ZIP file containing the individual CSV files, but the Auction System will provide each of the CSV files separately. We emphasize that the sample data files we release today are for illustrative purposes only; they do not reflect any predictions or assumptions about the actual bidding in the auction, the number of rounds, or the outcome of the auction.
