PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES
REGION 45 (WISCONSIN) PUBLIC SAFETY REGIONAL PLANNING COMMITTEES TO
HOLD 700 MHZ AND 800 MHZ PLANNING MEETINGS

The Region 45 (Wisconsin)¹ Regional Planning Committees (RPCs) will hold two consecutive planning meetings on Thursday, December 8, 2016. Beginning at 10:00 a.m., the 700 MHz RPC will convene at the City of Sheboygan Police Department, 1315 North 23rd Street, Sheboygan, Wisconsin. At 11:00 a.m., the Region 45 800 MHz RPC meeting will convene (preceding the East Central Regional Interoperability meeting) at the same location. The agenda for both the 700 and 800 MHz RPC meetings will include:

- Discussion on adjacent Regional Planning Committee requests
- Election of Region 45 Executive Committee members

Both Region 45 RPC meetings are open to the public. All eligible public safety providers in Region 45 may utilize these frequencies. It is essential that eligible public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.

All interested parties wishing to participate in planning for the use of public safety spectrum in the 700 MHz and 800 MHz bands within Region 45 should plan to attend. For further information, please contact:
