## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON VERIZON REQUEST FOR CLARIFICATION, OR IN THE ALTERNATIVE, PETITION FOR WAIVER OF COPPER RETIREMENT NOTIFICATION RULES REGARDING THE FORMAT OF THE LIST OF LOCATIONS AT WHICH THE CHANGES WILL OCCUR

The Wireline Competition Bureau seeks comment on a Request for Clarification, or in the Alternative, Petition for Waiver of Copper Retirement Notification Rules filed by Verizon.<sup>1</sup> In the Petition, Verizon requests that the Commission clarify that carriers may provide the public notice of copper retirement required by section 51.332 of the Commission's rules to all mandated recipients other than retail customers "with a paper copy of the notice and a hyperlink to a searchable online list of addresses or locations where copper is to be retired in lieu of a paper copy of the address list."<sup>2</sup> In the alternative, Verizon seeks a waiver of "any requirement that these parties be served with a paper address list when providers instead provide a copy of the notice and a hyperlink to a searchable online list."<sup>3</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments and reply comments on or before the dates indicated above. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS). *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first- class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

- All hand-delivered or messenger-delivered paper filings for the Commission's Secretary must be delivered to FCC Headquarters at 445 12<sup>th</sup> St., SW, Room TW-A325, Washington, DC 20554. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's exparte rules. Persons making exparte presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral ex parte presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the ex parte presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during ex parte meetings are deemed to be written ex parte presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written ex parte presentations and memoranda summarizing oral ex parte presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's ex parte rules.
