OFFICE OF ENGINEERING AND TECHNOLOGY DECLARES HEADSIGHT, INC.
REQUEST FOR WAIVER OF CERTAIN PART 15 ULTRA-WIDEBAND (UWB) RULES
TO BE A "PERMIT-BUT-DISCLOSE" PROCEEDING FOR *EX PARTE* PURPOSES
AND REQUESTS COMMENT

On January 21, 2016, Headsight, Inc. ("Headsight") filed a request for waiver of two Commission rules so it can obtain FCC certification to market a UWB device that would be used on farm equipment for various applications, such as detecting ground surface conditions that are obscured by crops and adjusting the height of "headers" on combines when harvesting different types of crops. The device would transmit in the band between 1 and 6 GHz.

Headsight states that its device is designed to comply with the Part 15 Subpart F emission limits for UWB ground penetrating radars (GPRs). It requests a waiver of Section 15.509(b) to allow its device to be used in agricultural applications. This rule section limits operation of GPRs and wall imaging systems to purposes associated with law enforcement, firefighting, emergency rescue, scientific research, commercial mining, or construction.

Headsight also requests a waiver of Section 15.503(f) to allow operation of its device at more than one meter above ground, but no more than one meter above crop height. This rule section requires that GPRs operate in contact with, or within one meter of the ground. Alternatively, Headsight requests that this rule section be interpreted so that the term "ground" may include "ground structures" such as crops.

The FCC's Office of Engineering and Technology (OET) is reviewing the waiver request. OET has concluded that in order to develop a complete record on the issues presented by this request, this proceeding will be treated, for *ex parte* purposes, as "permit-but-disclose" in accordance with Section 1.1200(a) of the Commission's rules, subject to the requirements under Section 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.149, interested parties may file comments and reply comments on or before the dates indicated on the first page of this document. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS). *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
