**PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES
REGION 33 (OHIO) REGIONAL PLANNING COMMITTEES TO HOLD 800 MHZ AND
700 MHZ MEETINGS**

The Region 33 (Ohio)¹ Public Safety Regional Planning Committees (RPCs) will hold two planning meetings on Wednesday, September 14, 2016. The meetings will be held following the Association of Public-Safety Communications Officials (APCO) and the National Emergency Number Association (NENA) meetings, between 10:15 a.m. - 11:30 a.m. The meetings will be held at the Ohio State Highway Patrol Academy, 740 East 17th Avenue, Columbus, Ohio, 43211.²

² The Ohio State Highway Patrol Academy is located just west of I-71 at the 17th Avenue exit.

Both Region 33 RPC meetings are open to the public. All eligible public safety providers in Region 33 may utilize these frequencies. It is essential that eligible public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.
