**WIRELINE COMPETITION BUREAU SEEKS COMMENT ON  
THE JOINT PETITION OF CHEYENNE RIVER SIOUX TRIBE TELEPHONE AUTHORITY  
AND CENTURYLINK QC TO WAIVE THE DEFINITION OF “STUDY AREA” CONTAINED  
IN PART 36 OF THE COMMISSION’S RULES**

The Wireline Competition Bureau (Bureau) seeks comment on the joint petition of Cheyenne River Sioux Tribe Telephone Authority (CRSTTA) and CenturyLink QC (CenturyLink) (together, Petitioners) for waiver of the definition of “study area.”<sup>1</sup> Petitioners state that the purpose of the waiver is to permit CenturyLink to transfer several households in CenturyLink study area 395145 to CRSTTA study area 391647.<sup>2</sup> Currently, CenturyLink does not provide service to any of the locations that are at issue in the petition, and no facilities will be transferred from CenturyLink to CRSTTA.<sup>3</sup> We also note that CenturyLink is not receiving Connect America Fund Phase II funding for these census blocks.<sup>4</sup>

CRSTTA estimates that it will cost approximately \$22,000 in total to build out to all five locations seeking service from CRSTTA and that the total annual increase in universal service support will be \$350 annually.<sup>5</sup> CRSTTA also recognizes that for purposes of any recovery related to intercarrier compensation, CRSTTA proposes to treat the relevant locations as new customers.<sup>6</sup> Petitioners state that

grant of the petition is in compliance with the standards set forth in the *USF/ICC Transformation Order*<sup>7</sup> and the public interest will be served by granting the waiver because the locations at issue were previously unserved.<sup>8</sup>

Effective November 15, 1984, the Commission froze all study area boundaries to prevent incumbent local exchange carriers from establishing separate study areas made up only of high-cost exchanges in order to maximize their receipt of high-cost universal service support.<sup>9</sup> A carrier must therefore apply to the Commission for a waiver of the study area boundary freeze if it wishes to transfer or acquire additional exchanges.

In the *USF/ICC Transformation Order*, the Commission streamlined its rules governing study area waiver requests, creating a method similar to the Bureau's processing of routine section 214 transfer of control applications.<sup>10</sup> In the past, the procedures for addressing petitions for study area waiver required the Bureau to issue an order either granting or denying the request after issuing a public notice. Under the revised process, upon determination that a petitioner has filed a complete petition and that the petition is appropriate for streamlined treatment, the Bureau will issue a public notice seeking comment on the petition, and the petition will be deemed granted 60 days after the reply comment due date absent further action by the Bureau.<sup>11</sup> Based on an initial review, the Bureau finds that the Petition is complete and is appropriate for streamlined treatment, and it therefore seeks comment on the Petition.<sup>12</sup>

Pursuant to sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before the dates indicated above.<sup>13</sup> All pleadings are to reference **WC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>14</sup>
