INTERCONNECTED VOIP NUMBERING AUTHORIZATION APPLICATION FILED BY MAGNA5 LLC PURSUANT TO SECTION 52.15(g)(3) OF THE COMMISSION'S RULES

STREAMLINED PLEADING CYCLE ESTABLISHED

WC Docket No. 17-216¹

Comments Due: November 30, 2017

On August 14, Magna5 LLC (Magna5) filed an application,² pursuant to section 52.15(g)(3) of the Commission's rules,³ seeking authorization to obtain North American Numbering Plan telephone numbers directly from the Numbering Administrators.⁴

In its application, supplements, and amendment, Magna5, an interconnected Voice over Internet Protocol (VoIP) provider, included the contact information and acknowledgements required by section 52.15(g)(3)(i) of the Commission's rules.⁵ In addition, Magna5 provided evidence that it will be capable of providing service within 60 days of the numbering resources activation date⁶ and certified that it complies with the contribution, regulatory fee, and 911 obligations set forth in section 52.15(g)(3)(i)(E).⁷

Magna5 also certified that it has the financial, managerial, and technical expertise to provide reliable service;⁸ that none of its key management and technical personnel are being or have been investigated by the Federal Communications Commission, or any law enforcement or regulatory agency, for failure to comply with any law, rule, or order;⁹ and that no party to the application is subject to a denial of Federal benefits pursuant to section 5301 of the Anti-Drug Abuse Act of 1988.¹⁰ Finally, Magna5 reported that it initially intends to request numbers in New York, Oregon, and Washington.¹¹

GENERAL INFORMATION

The Numbering Authorization Application identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any VoIP Numbering Authorization Application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 52.15(g)(3)(ii) of the Commission's rules,¹² interested parties may file comments in WC Docket No. 17-216 **on or before November 30, 2017**. Commenters must serve a copy of comments on Magna5 no later than the above comment filing date. Unless otherwise notified by the Commission, Magna5 may provide the states in which it intends to request numbers the required 30-day notice on the 31st day after the date of this notice.¹³

Pursuant to section 52.15(g)(3)(ii) of the Commission's rules,¹⁴ interested parties to this proceeding must file any documents in this proceeding using the Commission's Electronic Comment Filing System (ECFS): <http://apps.fcc.gov/ecfs/>.

The proceeding in this Notice will be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules. Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter’s written comments, memoranda, or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b).¹⁵ Participants in this proceeding should familiarize themselves with the Commission’s *ex parte* rules.
