COMMENT DEADLINES SET FOR NOTICE OF PROPOSED RULEMAKING TO UPDATE RULES GOVERNING ANCILLARY OR SUPPLEMENTARY SERVICES AND BROADCAST PUBLIC NOTICES

On October 24, 2017, the Commission released a *Notice of Proposed Rulemaking (NPRM)* in MB Docket No. 17-264 that proposes to update two provisions in Part 73 of its rules governing broadcast licensees: Section 73.624(g), which establishes certain reporting obligations relating to the provision of ancillary or supplementary services, and Section 73.3580, which sets forth requirements concerning public notice of the filing of broadcast applications.¹ The Commission set deadlines for filing comments and reply comments at 30 and 45 days, respectively, after publication of the *NPRM* in the Federal Register.² A summary of the *NPRM* was published in the Federal Register on November 29, 2017.³ Thus, comments must be submitted no later than December 29, 2017. Reply comments must be submitted no later than January 16, 2018. Commenters must follow the filing instructions provided in paragraph 20 of the *NPRM*.⁴ The *NPRM* is also available on the Commission's website.⁵
