## FCC ANNOUNCES THE SECOND MEETING OF THE BROADBAND DEPLOYMENT ADVISORY COMMITTEE

## GN Docket No. 17-83

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,<sup>1</sup> the Federal Communications Commission (FCC or Commission) announces the second meeting of the Broadband Deployment Advisory Committee (BDAC). The BDAC will hold its second meeting on **Thursday, July 20, 2017, beginning at 9:30 am,** in the Commission Meeting Room at FCC Headquarters, located at 445 12th Street, SW, Room TW-C305, Washington, DC 20554. Notice of this meeting will be published in the Federal Register.

At this meeting, the BDAC Working Groups will report on their progress in developing recommendations for the BDAC's consideration. The BDAC also will continue its discussions on how to accelerate the deployment of broadband by reducing and/or removing regulatory barriers to infrastructure investment. This agenda may be modified at the discretion of the BDAC Chair and the Designated Federal Officer (DFO).

The BDAC meeting is open to the public. The FCC will accommodate as many attendees as possible; however, admittance will be limited to seating availability. The Commission will also provide audio and/or video coverage of the meeting over the Internet from the FCC's web page at <u>www.fcc.gov/live</u>. Open captioning will be provided for this event. Other reasonable accommodations for people with disabilities are available upon request.
