FCC ANNOUNCES THE NEXT MEETING OF THE BROADBAND DEPLOYMENT ADVISORY COMMITTEE

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,¹ the Federal Communications Commission (FCC or Commission) announces the next meeting of the Broadband Deployment Advisory Committee (BDAC). The meeting will be held **Thursday and Friday**, **December 6 and 7, 2018, beginning at 9:00 a.m. each day**, in the Commission Meeting Room at FCC Headquarters, located at 445 12th Street, SW, Room TW-C305, Washington, DC 20554.

At this meeting, the BDAC will continue considering and will vote on the Model Code for States and hear a status report from the Disaster Response and Recovery Working Group. This agenda may be modified at the discretion of the BDAC Chair and the Designated Federal Officer (DFO).

The BDAC meeting is open to the public. The FCC will accommodate as many attendees as possible; however, admittance will be limited to seating availability. The Commission will also provide audio and/or video coverage of the meeting over the Internet from the FCC's web page at <u>www.fcc.gov/live</u>. Open captioning will be provided for this event. Other reasonable accommodations for people with disabilities are available upon request.
