**PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES
REGION 47 (PUERTO RICO) PUBLIC SAFETY REGIONAL PLANNING COMMITTEES TO
HOLD 700 MHZ AND 800 MHZ NPSPAC MEETINGS**

The Region 47 (Puerto Rico)¹ Public Safety Regional Planning Committees (RPCs) will hold two consecutive planning meetings on Thursday, June 7, 2018. Beginning at 9:00 a.m., the 700 MHz Public Safety RPC will convene at the Puerto Rico Homeland Security Affair Office, Road PR 1, Barrio Arenas.
