## DOMESTIC SECTION 214 APPLICATION GRANTED FOR THE ACQUISITION OF CERTAIN ASSETS OF 1 800 COLLECT, INC. BY 18C, LLC

### WC Docket No. 16-275

By this Public Notice, the Wireline Competition Bureau (Bureau) grants the application filed by 1 800 Collect, Inc. (1 800 Collect) and 18C, LLC (18C) (together, Applicants), pursuant to section 214 of the Communications Act of 1934, as amended, and section 63.03 of the Commission's rules, requesting consent to transfer certain assets and the domestic section 214 authorization held by 1 800 Collect to 18C.<sup>1</sup>

On September 23, 2016, the Bureau released a Public Notice requesting comment on the Application.<sup>2</sup> On October 12, 2016, the U.S. Department of Justice (DOJ), with the concurrence of the U.S. Department of Defense and the U.S. Department of Homeland Security (collectively, the Executive Branch Agencies), filed a letter requesting that the Commission defer action on this proceeding while they completed their review of any national security, law enforcement, and public safety issues.<sup>3</sup> We deferred action on the Application in response to the Executive Branch Agencies' request.<sup>4</sup>

On May 15, 2018, the DOJ, including the National Security Division and the Federal Bureau of Investigation, submitted a Petition to Adopt Conditions to Authorizations and Licenses (Petition).<sup>5</sup> In the Petition, DOJ advises the Commission that it has no objection to the Commission approving the authority sought in this proceeding, provided the Commission conditions its approval on the assurances of 1 800 Collect and 18C to abide by the commitments and undertakings set forth in the May 11, 2018 Letter of

Agreement (Agreement).<sup>6</sup> The DOJ filed the Petition and Agreement in WC Docket No. 16-275.<sup>7</sup>

The Bureau finds, upon consideration of the record, that grant of the Application, subject to compliance with the Agreement, will serve the public interest, convenience, and necessity.<sup>8</sup> Further, consistent with Commission precedent, the Bureau accords the appropriate level of deference to the Executive Branch Agencies' expertise on national security and law enforcement issues.<sup>9</sup> Therefore, pursuant to section 214 of the Act, 47 U.S.C. § 214, and sections 0.91 and 0.291 of the Commission's rules, 47 CFR §§ 0.91, 0.291, the Bureau hereby grants the Application discussed in this Public Notice subject to compliance with the Agreement described above. A failure to comply with and/or remain in compliance with any of the provisions of the Agreement shall constitute a failure to meet a condition of this authorization and thus grounds for declaring the underlying authorizations terminated without further action on the part of the Commission. Failure to meet a condition of this authorization may also result in monetary sanctions or other enforcement action by the Commission.

Pursuant to section 1.103 of the Commission's rules, 47 CFR § 1.103, the grant is effective upon release of this Public Notice. Petitions for reconsideration under section 1.106 or applications for review under section 1.115 of the Commission's rules, 47 CFR §§ 1.106, 1.115, may be filed within 30 days of the date of this Public Notice.
