## **RURAL BROADBAND AUCTIONS TASK FORCE RELEASES LIST OF HANDSETS TO BE USED IN MOBILITY FUND PHASE II CHALLENGE PROCESS SPEED TESTS**

The Rural Broadband Auctions Task Force (Task Force), in conjunction with the Wireline Competition Bureau and the Wireless Telecommunications Bureau (Bureaus), today releases a list of the handsets designated by each mobile wireless provider in the Mobility Fund Phase II (MF-II) challenge process for challengers to use when conducting speed tests in areas deemed presumptively ineligible for MF-II support.<sup>1</sup> The list of handsets is available as Appendix A to this public notice.

We remind entities participating or considering participating in the challenge process that all submitted speed test data must comply with all required specifications and, in order to be considered valid in the challenge process, must be substantiated by the certification of a qualified engineer or government official.<sup>2</sup>
