## COMMENT DEADLINES SET FOR NOTICE OF PROPOSED RULEMAKING ON AMENDMENT OF RULES REGARDING POSTING OF STATION LICENSES

Comment Date: August 1, 2018

Reply Comment Date: August 16, 2018

On May 10, 2018, the Federal Communications Commission released a *Notice of Proposed Rulemaking (NPRM)* in MB Docket No. 18-121 that proposes to eliminate or streamline provisions in Parts 0, 1, 5, 73, and 74 of the Commission's rules which mandate posting and maintenance of broadcast licenses and authorization information in specific locations, including the physical cite of broadcast facilities.<sup>1</sup> The Commission set deadlines for filing comments and reply comments at 30 and 45 days, respectively, after publication of the *NPRM* in the Federal Register.<sup>2</sup>

A summary of the NPRM was published in the Federal Register on July 2,  $2018.^3$  Accordingly, comments must be submitted no later than August 1, 2018. Reply comments must be submitted no later than August 15, 2018. Commenters must follow the filing instructions provided in paragraph 15 of the *NPRM*.<sup>4</sup>
