CONSUMER AND GOVERNMENTAL AFFAIRS BUREAU ANNOUNCES COMMENT DEADLINES FOR INTERNET PROTOCOL CAPTIONED TELEPHONE SERVICE FURTHER NOTICE OF PROPOSED RULEMAKING AND NOTICE OF INQUIRY

On June 8, 2018, the Federal Communications Commission (FCC or Commission) adopted a Report and Order, Declaratory Ruling, Further Notice of Proposed Rulemaking, and Notice of Inquiry in the above-referenced proceeding to modernize and reform the Internet Protocol Captioned Telephone Service (IP CTS) program.¹ For the Further Notice of Proposed Rulemaking (FNPRM), the Commission established a comment deadline of 60 days, and a reply comment deadline of 90 days, each after publication of a summary of the FNPRM in the *Federal Register*.² For the Notice of Inquiry (NOI), the Commission established a comment deadline of 90 days and a reply comment deadline of 120 days, each after publication of a summary of the NOI in the *Federal Register*.³

On July 18, 2018, the Federal Register published a summary of the FNPRM and NOI.⁴ Accordingly, comments pertaining to the FNPRM must be filed on or before September 17, 2018, and reply comments must be filed on or before October 16, 2018. Comments pertaining to the NOI must be filed on or before October 16, 2018, and reply comments must be filed on or before November 15, 2018.
