## WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON DISH REQUEST FOR WAIVER OF AWS-4 AND H-BLOCK EMISSION LIMITS

WT Docket No. 18-237

## Comments Due: August 20, 2018 Reply Comments Due: August 30, 2018

By this public notice, the Wireless Telecommunications Bureau ("Bureau") seeks comment on the request of DISH Network Corporation (DISH),<sup>1</sup> for waiver of Sections 27.53(h)(1) and 27.53(h)(2)(iv) of the Commission's rules (Request).<sup>2</sup>

DISH, the licensee of all 352 AWS-4 licenses and all 176 H-Block licenses nationwide, requests waiver of rules that limit out-of-band emissions from equipment operating (1) in the Upper H Block (1995-2000 MHz) into the Lower AWS-4 Band (2000-2020 MHz), and (2) in the Lower AWS-4 Block into the Upper H Block.<sup>3</sup> DISH states that "[no out-of-band emission] limits within the contiguous 1995-2020 MHz band are necessary . . . because both of these bands are licensed to DISH on a nationwide basis."<sup>4</sup> According to DISH, the requested waiver would "permit [it] and/or its equipment vendors to certify equipment that operates across both the Upper H Block and the Lower AWS-4 spectrum from 1995-2020 MHz with no out-of-band emission limits within the contiguous band and at levels attenuated by  $43 + 10 \log 10(P)$  outside those bands."<sup>5</sup>

<u>Ex Parte Rules—Permit-But-Disclose</u>: Pursuant to § 1.1200(a) of the Commission's rules, this <u>Request</u> shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's <u>ex</u> <u>parte</u> rules. Persons making <u>ex parte</u> presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral <u>ex parte</u> presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the <u>ex parte</u> presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments,

memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during <u>ex parte</u> meetings are deemed to be written <u>ex parte</u> presentations and must be filed consistent with Section 1.1206(b) of the Commission's rules.<sup>7</sup> In proceedings governed by Section 1.49(f) of the Commission's rules<sup>8</sup> or for which the Commission has made available a method of electronic filing, written <u>ex parte</u> presentations and memoranda summarizing oral <u>ex parte</u> presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's <u>ex parte</u> rules.
