**PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES
REGION 28 (EASTERN PENNSYLVANIA, SOUTHERN NEW JERSEY AND DELAWARE
AREA) REGIONAL PLANNING COMMITTEES TO HOLD 700 MHZ AND
800 MHZ MEETING**

The Region 28 (Delaware, Eastern Pennsylvania, and Southern New Jersey Area) Public Safety Regional Planning Committees (RPCs)¹ will hold a planning meeting on Tuesday, October 9, 2018. Beginning at 10:00 a.m., the 800 MHz RPC and 700 MHz RPC meeting will convene at the Delaware River and Bay Authority Police Department, Delaware Memorial Bridge Toll Plaza, Julia Building, 2nd Floor Training Room, 2162 New Castle Avenue, New Castle, Delaware.²

The Region 28 700 and 800 MHz RPC meetings are open to the public. All eligible public safety providers whose sole purpose or principal purpose is to protect the safety of life, health, or property within Region 28 would utilize these frequencies. It is essential that not only public safety, but all government, Native American Tribal, and non-governmental organizations eligible under Section 90.20 (800 MHz) or 90.523 (700 MHz) of the Commission's Rules be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not
