FCC ANNOUNCES THE SIXTH MEETING OF THE COMMUNICATIONS SECURITY, RELIABILITY, AND INTEROPERABILITY COUNCIL SCHEDULED FOR SEPTEMBER 28, 2018 AT FCC HEADQUARTERS

By this Public Notice, the Federal Communications Commission (FCC or Commission), consistent with the Federal Advisory Committee Act (FACA),¹ announces that the FCC's Communications Security, Reliability, and Interoperability Council (CSRIC or Council) will meet **Friday, September 28, 2018, beginning at 1:00 p.m.**, in the Commission Meeting Room at FCC Headquarters, located at 445 12th Street, SW, Room TW-C305, Washington, DC 20554. Notice of this meeting was published in the Federal Register on September 5, 2018.²

At the meeting, CSRIC members will consider and vote on a Working Group 1 Report on Small Carrier NG9-1-1 Transition Considerations and a Working Group 3 Report on Best Practices and Recommendations to Mitigate Security Risks to Emerging 5G Wireless Networks. Working Group 2 will provide an update on their progress.³

The CSRIC meeting is open to the public. The FCC will accommodate as many attendees as possible; however, admittance will be limited to seating availability. The Commission will also provide audio and/or video coverage of the meeting over the Internet from the FCC's web page at www.fcc.gov/live.
