The Region 48 700 MHz and 800 MHz NPSPAC Public Safety RPC meetings are open to the public. All eligible public safety providers in Region 48 may utilize these frequencies. It is essential that eligible public safety agencies in all areas of

government, including state, municipality, county, Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Commission's rules, 47 CFR § 90.523, be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.
