## **PUBLIC SAFETY & HOMELAND SECURITY BUREAU ANNOUNCES PARTIAL DEACTIVATION OF THE DISASTER INFORMATION REPORTING SYSTEM FOR HURRICANE FLORENCE**

### **DIRS deactivated for all counties in Georgia, South Carolina and Virginia DIRS remains active in North Carolina**

At the request of the Federal Emergency Management Agency, the Federal Communications Commission (FCC) has deactivated its Disaster Information Reporting System (DIRS)<sup>1</sup> for the following areas affected by Hurricane Florence:

**Communications providers do not need to provide any additional reporting in DIRS for these areas with respect to Hurricane Florence.** The FCC will, however, continue to monitor the status of communications services and work with providers and government partners in these areas as needed to support remaining restoration efforts.
