**Nature of Service:** Earth Exploration Satellite Service

On October 2, 2019, the Satellite Division granted, with conditions, special temporary authority to DG Consents Sub, Inc., for a period of 180 days, to continue to conduct telemetry, tracking, and command and data downlink of Earth Exploration Satellite Service operations with the WorldView-4 space station (formerly known as GeoEye-2) at an altitude between 425 kilometers and 525 kilometers, instead of its currently authorized altitude of 496 kilometers to 770 kilometers.

On October 3, 2019, the Satellite Division granted, with conditions, an additional 30 days of special temporary authority to Intelsat License LLC to continue to operate Intelsat 10's Ku-band beam over a new coverage area in the communications frequencies of 12.5-12.75 GHz (space-to-Earth) and 14.25-14.5 GHz (Earth-to-space).
