## WIRELINE COMPETITION BUREAU INVITES COMMENTS ON NANC RECOMMENDATIONS ON IMPLEMENTING THE NATIONAL SUICIDE HOTLINE IMPROVEMENT ACT OF 2018

WC Docket No. 18-336  
CC Docket No. 92-105

### Comments Due: June 7, 2019

On May 13, 2019, as directed by the Wireline Competition Bureau (Bureau),<sup>1</sup> the North American Numbering Council (NANC) submitted its recommendations<sup>2</sup> on issues the Commission must address in implementing the National Suicide Hotline Improvement Act of 2018 (Act).<sup>3</sup> Today, the Bureau invites comments from interested stakeholders on the recommendations in the NANC Report.

The Act directs the Commission to conduct a study, in coordination with the Assistant Secretary for Mental Health and Substance Use and the Secretary of Veterans Affairs, that examines the feasibility of designating a simple, easy-to-remember, 3-digit dialing code to be used for a national suicide prevention and mental health crisis hotline system.<sup>4</sup> The Act also directs the Commission to coordinate with the NANC in conducting this study.<sup>5</sup> The Commission is further directed to submit a report, not later than one year after the date of enactment of the Act, on the study required by the Act that recommends whether a particular N11 dialing code or other covered dialing code should be used for a national suicide prevention and mental health crisis hotline system. The NANC's recommendations on these matters will inform the Commission's study and report required by the Act.<sup>6</sup>

Pursuant to section 1.419 of the Commission's rules, 47 CFR § 1.419, interested parties may file comments on or before the date indicated above. All filings should refer to WC Docket No. 18-336 and

Proceedings WC Docket No. 18-336 and CC Docket No. 92-105 have been designated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>7</sup> Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in these proceedings should familiarize themselves with the Commission's *ex parte* rules.
