## FCC ANNOUNCES THE MEMBERSHIP OF TWO BROADBAND DEPLOYMENT ADVISORY COMMITTEE WORKING GROUPS

This Public Notice serves as notice that Federal Communications Commission Chairman Ajit Pai has appointed members to serve on two Broadband Deployment Advisory Committee (BDAC) working groups: (1) the Broadband Infrastructure Deployment Job Skills and Training Opportunities working group, and (2) the Increasing Broadband Investment in Low-Income Communities working group.<sup>1</sup> The members of these working groups are listed in Appendix A.
