**Nature of Service:** Fixed Satellite Service

On July 11, 2019 the Satellite Division granted, with conditions, the request of Intelsat License LLC to modify the authorization for the Intelsat 10-02 space station by extending the license term for Intelsat 10-02 through December 31, 2026. Intelsat 10-02 operates at 1.0 W.L. in the 3625-4200 MHz (space-to-Earth), 5850-6425 MHz (Earth-to-space), 10.95-11.2 GHz (space-to-Earth), 11.45-11.70 GHz (space-to-Earth), 12.50-12.75 (space-to-Earth), and 13.75-14.50 GHz (Earth-to-space) frequency bands.
