PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES REGION 20 (DISTRICT OF COLUMBIA, MARYLAND AND NORTHERN VIRGINIA) REGIONAL PLANNING COMMITTEES TO HOLD 700 MHZ AND 800 MHZ MEETINGS
