## FCC ANNOUNCES NEXT MEETING OF THE BROADBAND DEPLOYMENT ADVISORY COMMITTEE

## GN Docket No. 17-83

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,<sup>1</sup> the Federal Communications Commission (FCC or Commission) announces the next meeting of the Broadband Deployment Advisory Committee (BDAC). The meeting will be held **Thursday, September 19, 2019, beginning at 9:30 a.m.**, in the Commission Meeting Room at FCC Headquarters, located at 445 12th Street, SW, Room TW-C305, Washington, DC 20554.

At this meeting, the BDAC will receive status reports and updates from its three working groups: Disaster Response and Recovery, Increasing Broadband Investment in Low-Income Communities, and Broadband Infrastructure Deployment Job Skills and Training Opportunities. This agenda may be modified at the discretion of the BDAC Chair and the Designated Federal Officer (DFO).

The BDAC meeting is open to the public. The FCC will accommodate as many attendees as possible; however, admittance will be limited to seating availability. The Commission will also provide audio and/or video coverage of the meeting over the Internet from the FCC's web page at <u>www.fcc.gov/live</u>. Open captioning will be provided for this event. Other reasonable accommodations for people with disabilities are available upon request.
