FCC ANNOUNCES NEXT MEETING OF THE BROADBAND DEPLOYMENT ADVISORY COMMITTEE

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,¹ the Federal Communications Commission (FCC or Commission) announces the next meeting of the Broadband Deployment Advisory Committee (BDAC). The meeting will be held **Thursday, October 29, and Friday, October 30, 2020, beginning at 11 a.m. each day**, via conference call and available to the public via the Internet at <u>http://www.fcc.gov/live</u>.

At this meeting, the BDAC will consider and vote on reports and recommendations from the Increasing Broadband Investment in Low-Income Communities, Broadband Infrastructure Deployment Job Skills and Training Opportunities, and Disaster Response and Recovery working groups. This agenda may be modified at the discretion of the BDAC Chair and the Designated Federal Officer (DFO).

The BDAC meeting is open to the public on the Internet via live feed from the FCC's web page at <u>http://www.fcc.gov/live</u>. Open captioning will be provided for this event. Other reasonable accommodations for people with disabilities are available upon request.
