## **PURPLE COMMUNICATIONS, INC., SURRENDERS CONDITIONAL CERTIFICATION AND WITHDRAWS APPLICATION TO PROVIDE VIDEO RELAY SERVICE**

**CG Docket Nos. 03-123 and 10-51**

On February 7, 2020, Purple Communications, Inc. (PCI) notified the Federal Communications Commission that effective February 15, 2020, it surrenders its conditional certification to provide video relay service (VRS) and withdraws its application for certification to provide VRS.<sup>1</sup> PCI will become a wholly-owned subsidiary of CSDVRS, LLC. CSDVRS, LLC (which is changing its name to ZP Better Together, LLC) will continue to provide VRS under the sub-brands ZVRS and Purple, pursuant to its conditional certification to provide VRS.<sup>2</sup>
