On October 15, 2019, Astro Digital filed a request to be included in the processing round for NVNG MSS satellite operations in the 399.9-400.05 MHz and 400.15-401 MHz bands, which includes Myriota, Hiber Inc., and Spire Global.[1] Astro Digital's application for a constellation to provide Earth-exploration satellite service was subject to a separate accepted for filing notice that did not initiate a processing round, and was granted in part, when it was authorized to deploy and operate five satellites.[2] Its request to operate additional satellites in that constellation was deferred and remains pending. Astro Digital's constellation will use portions of the 399.9-400.05 MHz and 400.15-401 MHz bands for space operation services. Astro Digital's application is included in this processing round for the purpose of consideration of the pending portion of its application and any modification to its authorization resulting from consideration of the lead and competing applications in this processing round.
