**AUCTION OF PRIORITY ACCESS LICENSES FOR THE
3550-3650 MHZ BAND RESCHEDULED TO BEGIN JULY 23, 2020**

AUCTION 105 SHORT-FORM APPLICATION DEADLINE POSTPONED TO MAY 7, 2020

1. By this Public Notice, the Office of Economics and Analytics (OEA) and the Wireless Telecommunications Bureau (Bureau), announce postponement of certain dates and deadlines for participation in Auction 105, the auction of Priority Access Licenses for the 3550-3650 MHz band.¹ OEA and the Bureau take this action in order to protect the health and safety of Commission staff during the auction and so that parties have additional time to prepare to participate in Auction 105 given the COVID-19 pandemic.² All other dates and procedures announced in the *Auction 105 Procedures Public Notice* remain unchanged.
