## PETITION FOR RECONSIDERATION FILED IN PS DOCKET NO. 19-352

### PS Docket No. 19-352

On July 30, 2020, ZTE Corporation filed a petition for reconsideration of a Final Designation Order of the Public Safety and Homeland Security Bureau released on June 30, 2020 in PS Docket No. 19-352.<sup>1</sup>

In accordance with the Commission's rules, oppositions to this Petition for Reconsideration must be filed within 10 days after the petition is filed, or **August 10, 2020**.<sup>2</sup> Replies to oppositions must be filed within 7 days after the last day for filing oppositions.<sup>3</sup> Oppositions and replies to oppositions must be served on parties to the proceeding.<sup>4</sup>

Oppositions and replies to oppositions may be filed using the Commission's Electronic Comment Filing System (ECFS).

- Electronic Filers: Comments may be filed electronically using the internet by accessing the ECFS: <https://www.fcc.gov/ecfs/>.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing.

Filings can be sent by commercial courier or by the U.S. Postal Service. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission. **Filings will not be accepted via hand or messenger delivery.**

- Commercial deliveries (not including those sent using the U.S. Postal Service) must be sent to 9050 Junction Drive, Annapolis Junction, MD 20701.
- U.S. Postal Service First-Class, Express, and Priority mail must be addressed to 445 12<sup>th</sup> Street, SW, Washington, DC 20554.

Pursuant to the Commission's *ex parte* rules,<sup>5</sup> this is a "restricted" proceeding, in which *ex parte* presentations (other than those exempt under such rules) are prohibited. An *ex parte* presentation is any presentation which (1) if written, is not served on the parties to the proceeding; or (2) or if oral, is made without advance notice to the parties and without opportunity for them to be present.<sup>6</sup> Parties should familiarize themselves with the Commission's *ex parte* rules.
