## FCC ANNOUNCES FEBRUARY 26, 2020 MEETING OF DISABILITY ADVISORY COMMITTEE

By this Public Notice, consistent with the Federal Advisory Committee Act,<sup>1</sup> the Federal Communications Commission (FCC or Commission) announces the next meeting of the Disability Advisory Committee (DAC or Committee) to be held **Wednesday, February 26, 2020, at 9:00 a.m.**, Eastern Time, in the Commission Meeting Room at FCC Headquarters, located at 445 12<sup>th</sup> Street, SW, Room TW-C305, Washington, DC 20554.

At this meeting, DAC members will discuss (i) a report on the activities of its working group on enhanced Electronic Newsroom Technique (ENT) and other technologies for captioning live television programming; (ii) a working group report and recommendation regarding the Internet Protocol Captioned Telephone Service User Registration Database; (iii) meeting schedules; and (iv) any other topics relevant to the DAC's work. The meeting will be led by the DAC co-chairs: Brian Scarpelli, Senior Policy Counsel of ACT | The App Association, and Isidore Niyongabo, President and Director of Advocacy and Public Engagement of National Black Deaf Advocates.

The DAC may also receive briefings from Commission staff on issues of interest to the Committee and may discuss topics of interest to the Committee, including, but not limited to, matters concerning accessible communications, telecommunications relay services, emergency access, and video programming accessibility. This agenda may be modified at the discretion of the DAC Chairs and Designated Federal Officer (DFO).

The DAC meeting will be open to the public. The FCC will accommodate as many attendees as possible; however, admittance will be limited to seating availability. The FCC will also provide audio and video coverage of the meeting at [www.fcc.gov/live](http://www.fcc.gov/live). During the meeting, members of the public may submit questions and comments to the DAC via email: [livequestions@fcc.gov](mailto:livequestions@fcc.gov). These comments or questions may be addressed during the public comment period.
