## INTERNET PROTOCOL CAPTIONED TELEPHONE SERVICE: COMMENT DATES FOR RECONSIDERATION PETITIONS

CG Docket Nos. 13-24, 03-123, and 10-51

**Opposition Due Date: March 9, 2021**

**Reply Due Date: March 19, 2021**

On October 2, 2020, the Federal Communications Commission (Commission) released the *IP CTS Compensation Order*, in which the Commission set compensation rates for Internet Protocol Captioned Telephone Service (IP CTS) of \$1.42 per minute, effective December 1, 2020, through June 30, 2021, and \$1.30 per minute, effective July 1, 2021, through June 30, 2022.<sup>1</sup> T-Mobile USA, Inc. on behalf Sprint Communications Company L.P., and IDT Telecom, Inc. filed petitions for reconsideration.<sup>2</sup> Oppositions to the petitions are due 15 days after publication in the Federal Register, and replies are due 10 days after the date when comments are due.<sup>3</sup>

On February 22, 2021, a summary of the petitions was published in the Federal Register.<sup>4</sup> Accordingly, oppositions to the petitions must be filed by March 9, 2021, and replies must be filed by March 19, 2021.
