On January 14, 2021, the Satellite Division granted, with conditions, the request of Intelsat License LLC, as debtor-in-possession, for special temporary authority for a period of 180 days to continue to operate the beams of Intelsat 904 at 29.5° W.L. over a new coverage area in the 3625-4200 MHz (space-to-Earth) and 5850-6425 MHz (Earth-to-space) frequency bands.
