I. NOTICE OF CITATION

1. This **CITATION AND ORDER** (Citation), notifies Taneynet Broadband, Inc. d/b/a Wayvz Tech¹ (Taneynet Broadband) that it failed to file FCC Forms 477 two times and filed late one time. We therefore direct Taneynet Broadband to take immediate steps to comply with the FCC Form 477 reporting rules and instructions. If Taneynet Broadband fails to comply with these requirements, it may be liable for significant fines.

2. **Notice of Duty to Comply with the Law:** We issue this Citation pursuant to section 503(b)(5) of the Communications Act of 1934, as amended (Act), which states that the Commission may not impose monetary forfeitures against non-regulatees who violate Commission rules or the Act unless and until: (a) the Commission issues a citation to the violator; (b) the Commission provides the violator a reasonable opportunity to respond; and (c) the violator subsequently engages in conduct described in the citation.² Accordingly, Taneynet Broadband is hereby on notice that it must comply with sections 1.7001 and 1.7002 of the Commission's rules.³ If Taneynet Broadband subsequently engages in any conduct of the type this Citation describes — and specifically any violation of sections 1.7001 and 1.7002 of the Commission's rules — Taneynet Broadband may be subject to civil penalties, including but not limited to

substantial monetary forfeitures. In assessing such forfeitures, the Commission may consider both the conduct that led to this Citation and the conduct following it.⁴

II. BACKGROUND

3. To accomplish its broadband goals, the Federal Communications Commission (Commission or FCC) requires facilities-based broadband service providers to file FCC Form 477 twice each year. The March 1 filing reports data as of December 31 of the prior year, and the September 1 filing reports data as of June 30 of the current year.⁵ Form 477 contains important information that assists the Commission in carrying out its statutory mandates, including the requirement that the Commission “shall encourage the deployment on a reasonable and timely basis of advanced telecommunications capability to all Americans.”⁶ Form 477 filings contain service speed and subscriber information that the Commission uses to assess the state of broadband availability in the United States, and to take steps to further the goal of increasing that availability.⁷ The Commission uses data obtained from FCC Form 477 to “describe the deployment of broadband infrastructure,”⁸ and the collected data enable the Commission to appropriately target universal service funds to unserved and underserved regions and to meet public safety obligations. Federal and state agencies and the general public also benefit from the data reported on Form 477.

4. Since 2005, and beginning with the filing due September 1, 2005 for data as of June 30, 2005, the Commission has required “all facilities-based providers” of fixed and mobile broadband connections to end-users to submit counts of broadband connections in FCC Form 477.⁹ As explained in a related 2004 FCC news release, this includes facilities-based providers in rural areas, regardless of their size.¹⁰ Fixed wireless facilities-based broadband providers have been required to file both “deployment” and “subscription” data on their FCC Form 477 filings since 2014.¹¹ The Commission has underscored

the importance of timely and accurate FCC Form 477 filings through enforcement advisories and enforcement action.¹²

III. APPLICABLE LAW AND VIOLATIONS

5. Section 1.7001 of the Commission's rules requires, in relevant part that, "facilities-based providers of broadband service ... file FCC Form 477 data." Section 1.7002 of the Commission's rules requires this data must be filed semi-annually.¹³

6. Taneynet Broadband is a facilities-based provider of broadband connections to end users via fixed terrestrial wireless.¹⁴ The Commission requires broadband service providers, including Wireless Internet Service Providers (WISPs) such as Taneynet Broadband, to file data on their broadband services.

7. According to Taneynet Broadband, it began offering regulated services in 2016, and currently provides high speed wireless broadband service.¹⁵ Taneynet Broadband filed its Forms 477 due in March and September respectively for the years 2017 and 2018.¹⁶ However, Taneynet Broadband filed its Form 477 that was due on March 1, 2018 almost a month late.¹⁷ Additionally, Taneynet failed to file its FCC Forms 477 due on September 3, 2019, March 2, 2020, and March 15, 2021.¹⁸

8. Violations of the FCC Form 477 filing requirements are significant because FCC Form 477 is a critical fact-gathering instrument that informs the Commission's efforts to advance broadband availability. Moreover, in many instances service providers submitting FCC Form 477 data have the best, if not the only, reliable data about where their facilities are located and which areas they can serve. Timely data is essential to the mission of fostering the availability of broadband services across the United States, and failing to provide it materially impairs the Commission's ability to assess broadband deployment and to measure the subscribership upon which Commission policy is based.

9. We conclude that Taneynet Broadband violated sections 1.7001 and 1.7002 of the Commission's rules by failing to file three Forms 477 between 2019 and 2021, including its Form 477 that was due on March 15, 2021, and failing to timely file its Form 477 that was due on March 1, 2018.¹⁹

IV. OPPORTUNITY TO RESPOND TO THIS CITATION

10. Taneynet Broadband may respond to this Citation within 30 calendar days from the release date of this Citation by any of the following methods: (1) a written statement, (2) a teleconference interview, or (3) a personal interview at the Commission Field Office nearest to Taneynet Broadband's place of business. The Commission Field Office nearest Taneynet Broadband is located in Chicago, Illinois.

11. If Taneynet Broadband requests a teleconference or personal interview, contact Conor O'Donovan at (202) 418-1639. We note that such teleconference or interview must take place within 30 calendar days of the release date of this Citation. If Taneynet Broadband prefers to submit a written response with supporting documentation, it must send the response within 30 calendar days of the release date of this Citation to the contact and address provided in paragraph below.

12. All written communications must be mailed to Jeffrey J. Gee, Chief, Investigations and Hearings Division, Enforcement Bureau, Federal Communications Commission, 45 L Street, NE, Washington, DC 20554, and must include the Case No. referenced in the caption. The written statement shall also be emailed to Jeffrey J. Gee at Jeffrey.Gee@fcc.gov and to Conor O'Donovan at Conor.O'Donovan@fcc.gov.

13. Upon request, the Commission will make reasonable accommodations for persons with disabilities. If applicable, Taneynet Broadband should provide a description of the accommodation required, and include as much detail as possible, and also provide a telephone number and other contact information. Taneynet Broadband should allow at least five business days advance notice; last minute requests will be accepted, but may be impossible to fill. 14. We advise Taneynet Broadband that it is a violation of section 1.17 of the Commission's rules²⁰ for any person to make any false or misleading written or oral statement of fact to the Commission. Specifically, no person shall:

(1) In any written or oral statement of fact, intentionally provide material factual information that is incorrect or intentionally omit material information that is necessary to prevent any material factual statement that is made from being incorrect or misleading; and

(2) In any written statement of fact, provide material factual information that is incorrect or omit material information that is necessary to prevent any material factual statement that is made from being incorrect or misleading without a reasonable basis for believing that any such material factual statement is correct and not misleading.

15. Further, the knowing and willful making of any false statement, or the concealment of any material fact, in reply to this Citation is punishable by fine or imprisonment.²¹

16. Violations of section 1.17 of the Commission's rules or the criminal statute referenced above may result in further legal action, including monetary forfeitures pursuant to section 503 of the Act.

17. Finally, we warn Taneynet Broadband that, under the Privacy Act of 1974,²² Commission staff will use all relevant material information before it, including information disclosed in interviews or written statements, to determine what, if any, enforcement action is required to ensure Taneynet Broadband's compliance with the Act and the Commission's rules.²³

V. FUTURE VIOLATIONS

18. If, after receipt of this Citation, Taneynet Broadband again violates sections 1.7001 and 1.7002 of the Commission's rules by engaging in conduct of the type described herein, the Commission may impose monetary sanctions for each such violation.²⁴ The Commission may further adjust the forfeiture reflecting enumerated statutory factors, which include the nature, circumstances, extent, and gravity of the violation, and with respect to the violator, the degree of culpability, any history of prior offenses, ability to pay, and other such matters as justice may require. Further, as discussed above, the Commission may assess forfeitures on both the conduct that led to this Citation and the conduct following it.

VI. ORDERING CLAUSES

19. Accordingly, **IT IS ORDERED** that, pursuant to sections 4(i) and 4(j) of the Act,²⁵ Taneynet Broadband, Inc. must cease and desist from failure to file and failure to timely file FCC Forms 477, in violation of sections 1.7001 and 1.7002 of the Commission's rules.²⁶
