## FCC ANNOUNCES THE SIXTH MEETING OF THE COMMUNICATIONS SECURITY, RELIABILITY, AND INTEROPERABILITY COUNCIL VIII ON DECEMBER 15, 2022

This Public Notice serves as an announcement that, consistent with the Federal Advisory Committee Act,<sup>1</sup> the Federal Communications Commission (FCC or Commission) will hold the sixth meeting of the Communications Security, Reliability and Interoperability Councill VIII (CSRIC VIII or Council) on Thursday, December 15, 2022, beginning at 1:00 pm EST, at the FCC, 45 L Street NE, Washington, DC, and via conference call.
