On January 10, 2022, the Satellite Division granted-in-part, with conditions, modification of the grant of United States market access to Spire Global, Inc. for its MINAS constellation, to grant market access for two additional satellites, to be deployed to a circular orbit at an altitude of no greater than 550 km, prior to completion of the Commission's review of the supplemented orbital debris mitigation plan, including for operations only with earth stations in the United States in the 2020-2025 MHz (space-to-Earth) frequency band.
