## ANNOUNCEMENT OF COMMENT AND REPLY COMMENT DATES FOR CLOSED CAPTIONING DISPLAY SETTINGS PUBLIC NOTICE

**MB Docket No. 12-108**

**Comments Due: February 17, 2022**  
**Reply Comments Due: March 4, 2022**

On January 10, 2022, the Media Bureau released a Public Notice (*Record Refresh PN*)<sup>1</sup> seeking to refresh the record on rules initially proposed in 2015 that would require manufacturers of covered apparatus and multichannel video programming distributors (MVPDs) to make closed captioning display settings readily accessible to individuals who are deaf and hard of hearing under the Television Decoder Circuitry Act of 1990 (TDCA).<sup>2</sup> The *Record Refresh PN* set deadlines for filing comments and reply comments at 30 and 45 days, respectively, after publication of the *Record Refresh PN* in the Federal Register.<sup>3</sup>

By this Public Notice, the Media Bureau announces that the *Record Refresh PN* was published in the Federal Register on January 18, 2022.<sup>4</sup> Comments must be submitted no later than February 17, 2022. Reply Comments must be submitted no later than March 4, 2022. Commenters should review the filing requirements provided in the *Record Refresh PN*.<sup>5</sup> The *Record Refresh PN* is also available on the Commission's website.<sup>6</sup>
