FCC ANNOUNCES THE FOURTH MEETING OF THE COMMUNICATIONS SECURITY, RELIABILITY, AND INTEROPERABILITY COUNCIL VIII ON JUNE 15, 2022

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,¹ the Federal Communications Commission (FCC or Commission) will hold the fourth meeting of the Communications Security, Reliability and Interoperability Council VIII (CSRIC VIII) on **Wednesday, June 15, 2022, beginning at 1:00 pm EDT, via conference call and available to the public via the Internet at <http://www.fcc.gov/live>**. Notice of this meeting was published in the Federal Register on June 10, 2022.²

CSRIC VIII's fourth meeting will include presentations from the WG chairs on plans and progress on the assigned tasks. The CSRIC VIII meeting is open to the public.

The meeting is being held in a wholly electronic format in light of restrictions related to the COVID-19 pandemic.
