## BAAZ BROADCASTING CORPORATION SEEKS FOREIGN OWNERSHIP RULING PURSUANT TO SECTION 310(b)(4) OF THE COMMUNICATIONS ACT OF 1934, AS AMENDED

## PLEADING CYCLE ESTABLISHED

BAAZ Broadcasting Corporation (BAAZ)<sup>1</sup> filed a petition for declaratory ruling (Amended Petition) requesting that the Federal Communications Commission (Commission) find, pursuant to section 310(b)(4) of the Communications Act of 1934, as amended, (Act)<sup>2</sup> and section 1.5000(a)(1) of the Commission's rules,<sup>3</sup> that it would serve the public interest to allow BAAZ to accept foreign investment in excess of the 25% benchmarks set forth in section 310(b)(4) of the Act.<sup>4</sup> Specifically, BAAZ seeks a Commission ruling to (1) permit 100% aggregate indirect foreign investment (voting and equity) in the

company, and (2) specifically approve<sup>5</sup> Sukhdev S. Dhillon, a citizen of Canada, to hold 100% of the voting and equity interests in the licensee's controlling U.S. parent.<sup>6</sup>

BAAZ seeks this declaratory ruling in connection with the proposed transfer of control of AM broadcast station KNTS, Seattle, WA (Facility ID No. 87153) licensed to BAAZ. As detailed in the Amended Petition and the related Application for transfer of control, BAAZ (a U.S. corporation registered in the state of Washington) presently is owned 80% by Mohan Cheema, a U.S. citizen, and 20% by Sukhdev S. Dhillon, a Canadian citizen. Pursuant to the proposed transfer of control, a newly formed corporation, Amar Broadcasting, Inc. (Amar Broadcasting), a U.S. corporation registered in the state of Washington, would obtain 100% of the voting and equity interests in BAAZ from Mohan Cheema and Sukhdev S. Dhillon. In turn, Amar Broadcasting would be 100% owned by Sukhdev S. Dhillon.<sup>7</sup>

As the proposed transfer of control would result in the ownership of BAAZ changing from 80% U.S. owned to 100% foreign owned, the Amended Petition seeks a declaratory ruling to increase BAAZ's aggregate foreign ownership interests from a combined pre-transfer interest of 20% (equity and voting), to a post-transfer aggregate foreign ownership interest of 100% (equity and voting).<sup>8</sup> In addition, the Amended Petition seeks specific approval<sup>9</sup> for Sukhdev S. Dhillon, a Canadian citizen, to hold a 100% direct interest in Amar Broadcasting, Inc., the licensee's controlling U.S. parent.<sup>10</sup>

BAAZ asserts that grant of the Amended Petition will serve the public interest as it would further the Commission's stated goals of encouraging foreign investment in U.S. broadcast stations and the continuation of operations of such stations.<sup>11</sup> Further, BAAZ asserts that it "will remain, a minorityowned broadcaster of Punjabi-language radio programming to the Southeast Asian community in Seattle, Washington," and that the infusion of additional capital resulting from the proposed transaction would allow BAAZ to continue and enhance its provision of both locally-produced and internationally-sourced Punjabi-language programming to Seattle listeners.<sup>12</sup> Accordingly, BAAZ submits that grant of the Amended Petition would serve the public interest.

Pursuant to Commission practice, the Amended Petition will be referred to relevant Executive Branch agencies for their views on any national security, law enforcement, foreign policy, or trade policy concerns related to the foreign ownership of BAAZ.<sup>13</sup>

## **EX PARTE STATUS OF THIS PROCEEDING**

Pursuant to section 1.1200(a) of the Commission's rules,<sup>14</sup> the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires. We announce that this proceeding will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under section 1.1206 of the Commission's rules.<sup>15</sup>

Parties making oral *ex parte* presentations are directed to the Commission's *ex parte* rules. Parties are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.<sup>16</sup> More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>17</sup> Other rules pertaining to oral and written presentations are set forth in section 1.1206(b) as well.<sup>18</sup>

## **GENERAL INFORMATION**

The petition for declaratory ruling referred to in this Public Notice has been accepted for filing upon initial review. The Commission reserves the right to return any filing if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies. Interested persons must file comments no later than **November 20, 2023**. Replies must be filed no later than **December 5, 2023**.

To allow the Commission to fully consider all substantive issues regarding the Amended Petition in as timely and efficient a manner as possible, commenters should raise all issues in their initial filings. A party or interested person seeking to raise a new issue after the pleading cycle has closed must show good cause why it was not possible for it to have raised the issue previously.<sup>19</sup> Submissions after the pleading cycle has closed that seek to raise new issues based on new facts or newly discovered facts should be filed within 15 days after such facts are discovered. Absent such a showing of good cause, any issues not timely raised may be disregarded by the Commission.

All filings concerning matters referenced in this Public Notice should refer to MB Docket No. 23-356, as well as the specific file number of any relevant individual application or other matters to which the filings pertain.

Submissions in this matter may be filed electronically (i.e., through ECFS) or by filing paper copies.
