#### FORFEITURE ORDER

Adopted: November 3, 2023

#### I. INTRODUCTION

1. In this *Forfeiture Order*, we issue a monetary forfeiture in the amount of one thousand five hundred dollars (\$1,500) to Glendive Broadcasting Corporation (Licensee), licensee of TV translator station K13IG-D Sidney-Fairview, Montana (Station). We find that the Licensee willfully violated section 73.3539(a) of the Commission's rules (Rules) by failing to timely file license renewal application for the Station.<sup>1</sup>

# II. BACKGROUND

2. Section 73.3539(a) of the Rules requires that applications for renewal of license for broadcast stations must be filed "not later than the first day of the fourth full calendar month prior to the expiration date of the license sought to be renewed."<sup>2</sup> An application for renewal of the Station's license should have been filed by December 1, 2021, the first day of the fourth full calendar month prior to the Station's license expiration date of April 1, 2022.<sup>3</sup> The Application was not filed until January 19, 2022. At the time of filing, the Licensee provided no explanation for its untimely filing of the Application.

3. Accordingly, on July 20, 2023, we released a *Memorandum Opinion and Order and Notice of Apparent Liability for Forfeiture (NAL)* that proposed a forfeiture of one thousand five hundred dollars (\$1,500).<sup>4</sup> The *NAL* gave the Licensee thirty days to pay the full amount of the proposed forfeiture, or file a written statement seeking reduction or cancellation of the proposed forfeiture.<sup>5</sup> To date, the Licensee has neither paid the proposed forfeiture nor filed a written statement in response to the *NAL*. A copy of the NAL was received by the Licensee on July 25, 2023.<sup>6</sup>

# III. DISCUSSION

4. The forfeiture amount proposed in this case was assessed in accordance with section 503(b) of the Communications Act of 1934, as amended (the Act),<sup>7</sup> section 1.80 of the Rules,<sup>8</sup> and the Commission's Forfeiture Policy Statement.<sup>9</sup> In assessing forfeitures, section 503(b)(2)(E) of the Act requires that we take into account the nature, circumstances, extent, and gravity of the violation, and, with respect to the violator, the degree of culpability, any history of prior offenses, ability to pay, and such other matters as justice may require.<sup>10</sup>

5. The Application was due on December 1, 2021, but was not filed until January 19, 2022 – over one month late. The Licensee was afforded an opportunity to either pay or respond to the *NAL* pursuant to section 1.80 of the Rules,<sup>11</sup> but has failed to either pay the proposed forfeiture or seek reduction or cancellation of it within the time period set forth in the *NAL*. Accordingly, we conclude that the Licensee willfully violated section 73.3539 of the Rules and we issue a forfeiture in the amount of \$1,500 as proposed in the *NAL*.<sup>12</sup>

# IV. ORDERING CLAUSES

6. **IT IS ORDERED**, pursuant to section 503(b) of the Communications Act of 1934, 47 U.S.C. § 503(b), as amended, and sections 0.283 and 1.80 of the Commission's rules, 47 CFR §§ 0.283 and 1.80, that Glendive Broadcasting Corporation, **IS LIABLE FOR A MONETARY FORFEITURE** in the amount of one thousand five hundred dollars (\$1,500) for its apparent willful violation of section 73.3539(a) of the Commission's rules, 47 CFR § 73.3539(a).

7. Payment of the forfeiture must be made by credit card, ACH (Automated Clearing House) debit from a bank account using the Commission's CORES (the Commission's online payment system),<sup>13</sup> or by wire transfer. The Commission no longer accepts forfeiture payments by check or money order. Upon payment, Licensee must send notice that payment has been made to <u>VideoNAL@fcc.gov</u>. Below are instructions that payors should follow based on the form of payment selected:<sup>14</sup>

• Payment by wire transfer must be made to ABA Number 021030004, receiving bank TREAS/NYC, and Account Number 27000001. A completed Form 159 must be faxed to the Federal Communications Commission at 202-418-2843 or e-mailed to <u>RROGWireFaxes@fcc.gov</u> on the same business day the wire transfer is initiated. Failure to provide all required information in Form 159 may result in payment not being recognized as having been received. When completing FCC Form 159, enter the Account Number in block number 23A (call sign/other ID), enter the letters "FORF" in block number 24A (payment

type code), and enter in block number 11 the FRN(s) captioned above (Payor FRN).<sup>15</sup> For additional detail and wire transfer instructions, go to <u>https://www.fcc.gov/licensing-databases/fees/wire-transfer</u>.

- Payment by credit card must be made by using the Commission's Registration System (CORES) at <a href="https://apps.fcc.gov/cores/userLogin.do">https://apps.fcc.gov/cores/userLogin.do</a>. To pay by credit card, log-in using the FCC Username associated to the FRN captioned above. If payment must be split across FRNs, complete this process for each FRN. Next, select "Manage Existing FRNs | FRN Financial | Bills & Fees" from the CORES Menu, then select FRN Financial and the view/make payments option next to the FRN. Select the "Open Bills" tab and find the bill number associated with the NAL/Acct. No. The bill number is the NAL Acct. No. (e.g., NAL/Acct.
