By the Chief, Audio Division, Media Bureau:

1. In this Order, we adopt the attached Consent Decree entered into by the Media Bureau (Bureau) and CSN International, Inc. (CSN), the licensee/permittee of the stations listed in section II of the Appendix and the proposed assignee of the stations listed in section I of the Appendix. The Consent Decree resolves issues arising from the Bureau’s review of the above-captioned applications for Commission consent to the proposed assignment of licenses and transfer of control of CSN (Assignment and Transfer Applications).

2. The Consent Decree resolves the Bureau’s investigation of CSN’s compliance with

section 1.17 of the Commission's rules (Rules).<sup>1</sup> Specifically, CSN failed to disclose that it had not reported some members of its governing board on various applications as required by the application instructions and the Commission's rules, contrary to CSN's certifications that the applications were complete and satisfied the relevant Commission criteria.<sup>2</sup>

3. Pursuant to the terms of the Consent Decree, CSN stipulates that it violated section 1.17 of the Rules. The Consent Decree requires, among other things, that CSN make a ten thousand dollar (\$10,000) civil penalty payment to the United States Treasury. A copy of the Consent Decree is attached hereto and incorporated by reference.

4. After reviewing the terms of the Consent Decree, we find that the public interest will be served by its approval and by terminating all pending proceedings related to the Bureau's investigation of potential violations of the Rules and the Act in connection with the Assignment and Transfer Applications.

5. Based on the record before us, we conclude that nothing in the record creates a substantial and material question of fact as to whether CSN possesses the basic qualifications to hold a Commission license or authorization.

6. ACCORDINGLY, IT IS ORDERED that, pursuant to section 4(i) of the Act,<sup>3</sup> and by the authority delegated by sections 0.61 and 0.283 of the Rules,<sup>4</sup> the Consent Decree attached hereto IS ADOPTED without change, addition, or modification.

7. IT IS FURTHER ORDERED that the investigation by the Bureau of the matters noted above ARE TERMINATED.

**CONSENT DECREE**

**I. INTRODUCTION**

1. This Consent Decree is entered into by and between the Media Bureau (Bureau) of the Federal Communications Commission and CSN International, Inc. (CSN), for the purpose of terminating the Bureau’s investigation into CSN’s compliance with section 1.17 of the Commission’s rules (Rules) in connection with the above-captioned assignment and transfer of control applications.<sup>1</sup> To resolve these matters, CSN agrees to pay a civil penalty of \$10,000.

## II. DEFINITIONS

2. For purposes of this Consent Decree, the following definitions shall apply:
- (a) “Act” means the Communications Act of 1934, as amended, 47 U.S.C. § 151 *et seq.*;
  - (b) “Adopting Order” means the order of the Bureau adopting this Consent Decree;
  - (c) “Assignment Applications” means the FCC Form 2100, Schedule 314 applications for consent to assignment of broadcast station licenses, Application File Nos. 0000197399 *et seq.*, 0000194181 *et seq.*, and 0000202702;
  - (d) “Bureau” means the Media Bureau of the Federal Communications Commission;
  - (e) “Civil Penalty” means the payment CSN has agreed to pay to the United States Treasury;
  - (f) “Commission” or “FCC” means the Federal Communications Commission and all of its bureaus and offices;
  - (g) “CSN” means CSN International, Inc.;
  - (h) “Effective Date” means the date on which the Bureau releases the Adopting Order;
  - (i) “Investigation” means the Bureau’s investigation of the information contained in the Assignment and Transfer Applications, as detailed herein;
  - (j) “Parties” mean CSN and the Bureau, each of which is a “Party”;
  - (k) “Rules” mean the FCC’s rules, found in Title 47 of the Code of Federal Regulations;
  - (l) “Transfer Applications” means the FCC Form 2100, Schedule 315 applications for consent to transfer of control, Application File Nos. 0000205167, *et seq.*, and 0000213714 *et seq.*;
  - (m) “Violations” means CSN’s failure to disclose on the Assignment Applications, as originally filed, and previous applications that CSN had not reported all of its governing board members as parties to the applications, contrary to its certifications on each application that all statements made in the application were complete, in violation section 1.17 of the Rules.

## III. BACKGROUND

3. Section 1.17 of the Rules states that no person may provide, in any written statement of fact, “material factual information that is incorrect or omit material information that is necessary to prevent any material factual statement that is made from being incorrect or misleading without a reasonable basis for believing that any such material factual statement is correct and not misleading.”<sup>2</sup> Even absent an intent to deceive, a false statement may constitute an actionable violation of Section 1.17 if it is submitted without a reasonable basis for believing that the statement is correct and not misleading.<sup>3</sup>

4. Among other things, the broadcast non pro forma assignment of license application forms and instructions require the disclosure of information about the proposed assignee and all parties to the

application.<sup>4</sup> For an entity such as CSN, which is not a for-profit corporation, partnership, or limited liability company, each executive officer, member of the governing board, and owner or holder of 5% or more of the votes in the applicant is considered a party to the application.<sup>5</sup>

5. On each of the Assignment Applications, CSN listed only the members of the governing board's executive committee as parties to the application but did not disclose that it was doing so.<sup>6</sup> In each case CSN certified that it answered each question on the application based on its review of the application instructions, that the application satisfied each of the pertinent standards and criteria set forth in the application instructions, and that all statements made in the application were true, complete, correct, and made in good faith.<sup>7</sup> Because CSN did not disclose that it reported only some of its governing board members, its certifications that all statements made in the applications were complete was false.<sup>8</sup> Only after Commission staff inquired about the accuracy of the information did CSN disclose that it had not reported some members of its governing board, contrary to its representations on the Assignment Applications, and that it had also done so on previous applications.<sup>9</sup> CSN then filed the pending Transfer Applications for its existing stations and amended the Assignment Applications to report all the members of its governing board.

6. The Bureau and CSN have negotiated the terms of this Consent Decree that terminates the Investigation into the matters discussed above. As part of this Consent decree, CSN agrees to make a Civil Penalty payment of ten thousand dollars (\$10,000) to the U.S. Treasury.

#### IV. TERMS OF AGREEMENT

7. **Adopting Order.** The provisions of this Consent Decree shall be incorporated by the Bureau in an Adopting Order.

8. **Jurisdiction.** CSN agrees that the Bureau has jurisdiction over it and the matters contained in this Consent Decree and the authority to enter into and adopt this Consent Decree.

9. **Effective Date; Violations.** The Parties agree that this Consent Decree shall become effective on the Effective Date as defined herein. Upon the Effective Date, the Adopting Order and this Consent Decree shall have the same force and effect as any other order of the Commission. CSN agrees that it is required to comply with each individual condition of this Consent Decree. Each specific condition is a separate condition of the Consent Decree as approved. Any violation of the Adopting Order or the terms of this Consent Decree shall constitute a separate violation of a Commission order, entitling the Commission to exercise any rights and remedies attendant to enforcement of a Commission order.

10. **Termination of Investigation.** In express reliance on the covenants and representations in this Consent Decree and to avoid further expenditure of public resources, the Bureau agrees to terminate the Investigation. In consideration for the termination of the Investigation, CSN agrees to the terms, conditions, and procedures contained herein.

11. The Bureau further agrees that, in the absence of new material evidence, it will not use the Violations or the existence of this Consent Decree in any action against CSN concerning the matters

that were the subject of the Investigation, provided that CSN satisfies all of its obligations under this Consent Decree. In the event that CSN fails to satisfy any obligations under this Consent Decree, the Bureau may take any enforcement action available pursuant to the Act and the Rules with respect to each Violation, and/or the violation of this Consent Decree.

12. **Admission of Liability.** CSN stipulates for purposes of this Consent Decree that it violated section 1.17 of the Rules by failing to disclose on the Assignment Applications, as originally filed, and previous applications that CSN had not reported all of its governing board members as parties to the applications, contrary to its certification on each application that all statements made in the application were complete. CSN acknowledges that the Commission or its delegated authority may consider CSN's admission of liability in this Consent Decree in proposing any future forfeiture against CSN in the event that CSN is determined to have apparently committed a violation of the Act, the Rules, or of any orders of the Commission after the Effective Date, whether related to the accuracy of CSN's application certifications or otherwise.

13. **Civil Penalty.** CSN agrees to make the Civil Penalty payment to the United States Treasury in the amount of Ten Thousand Dollars (\$10,000), within thirty (30) calendar days of the Effective Date. CSN acknowledges and agrees that upon execution of this Consent Decree, the Civil Penalty shall become a "Claim" or "Debt" as defined in Section 3701(b)(1) of the Debt Collection Improvement Act of 1996.<sup>10</sup>

14. **Payment.** CSN shall send electronic notification of payment of the Civil Penalty to Joseph Cohen at [Joseph.Cohen@fcc.gov](mailto:Joseph.Cohen@fcc.gov) and Christopher Clark at [Christopher.Clark@fcc.gov](mailto:Christopher.Clark@fcc.gov) on the date said payment is made. Payment of the Civil Penalty must be made by credit card, ACH (Automated Clearing House) debit from a bank account using CORES (the Commission's online payment system),<sup>11</sup> or by wire transfer. The Commission no longer accepts Civil Penalty payments by check or money order. Below are instructions that payors should follow based on the form of payment selected:<sup>12</sup>

- Payment by wire transfer must be made to ABA Number 021030004, receiving bank TREAS/NYC, and Account Number 27000001. A completed Form 159 must be faxed to the Federal Communications Commission at 202-418-2843 or e-mailed to [RROGWireFaxes@fcc.gov](mailto:RROGWireFaxes@fcc.gov) on the same business day the wire transfer is initiated. Failure to provide all required information in Form 159 may result in payment not being recognized as having been received. When completing FCC Form 159, enter the Account Number in block number 23A (call sign/other ID), enter the letters "FORF" in block number 24A (payment type code), and enter in block number 11 the FRN(s) captioned above (Payor FRN).<sup>13</sup> For additional detail and wire transfer instructions, go to <https://www.fcc.gov/licensing-databases/fees/wire-transfer>.
- Payment by credit card must be made by using the Commission's Registration System (CORES) at <https://apps.fcc.gov/cores/userLogin.do>. To pay by credit card, log-in using the FCC Username associated to the FRN captioned above. If payment must be split across FRNs, complete this process for each FRN. Next, select "Manage Existing FRNs | FRN Financial | Bills & Fees" from the CORES Menu, then select FRN Financial and the view/make payments option next to the FRN. Select the "Open Bills" tab and find the bill number associated with the NAL/Acct. No. The bill number is the NAL Acct. No. (e.g.,

NAL/Acct. No. 1912345678 would be associated with FCC Bill Number 1912345678). After selecting the bill for payment, choose the “Pay by Credit Card” option. Please note that there is a \$24,999.99 limit on credit card transactions.

- Payment by ACH must be made by using the Commission’s Registration System (CORES) at <https://apps.fcc.gov/cores/paymentFrnLogin.do>. To pay by ACH, log in using the FRN captioned above. If payment must be split across FRNs, complete this process for each FRN. Next, select “Manage Existing FRNs | FRN Financial | Bills & Fees” on the CORES Menu, then select FRN Financial and the view/make payments option next to the FRN. Select the “Open Bills” tab and find the bill number associated with the NAL/Acct. No. The bill number is the NAL/Acct. No. (e.g., NAL/Acct. No. 1912345678 would be associated with FCC Bill Number 1912345678). Finally, choose the “Pay from Bank Account” option. Please contact the appropriate financial institution to confirm the correct Routing Number and the correct account number from which payment will be made and verify with that financial institution that the designated account has authorization to accept ACH transactions.

15. **Qualifications; Agreement to Grant.** The Bureau finds that its Investigation raises no substantial and material questions of fact as to whether CSN possesses the basic qualifications, including those relating to character, to hold a Commission license or authorization. Accordingly, the Bureau agrees to grant the Assignment and Transfer Applications after the Effective Date, provided that the following conditions have been met: 1) the Civil Penalty payment, referenced in paragraph 13 of this Decree, has been fully and timely satisfied; and 2) there are no issues other than the Violations that would preclude grant of the Assignment and Transfer Applications.

16. **Waivers.** CSN agrees to waive any and all rights it may have to seek administrative or judicial reconsideration, review, appeal, or stay, or to otherwise challenge the validity of this Consent Decree and the Adopting Order, provided the Consent Decree is adopted without change, addition or modification. If any Party (or the United States on behalf of the Commission) brings a judicial action to enforce the terms of the Consent Decree or Adopting Order, no Party will contest the validity of the Consent Decree or Adopting Order, and CSN will waive any statutory right to a *trial de novo*. CSN further agrees to waive any claims they may otherwise have under the Equal Access to Justice Act, 5 U.S.C. Section 504 and Section 1.1501 *et. seq.* of the Rules relating to the Consent Decree or Adopting Order.

17. **Severability.** The Parties agree that if a court of competent jurisdiction renders any of the provisions of this Consent Decree unenforceable, such unenforceability shall not render unenforceable the Consent Decree, but rather the entire Consent Decree shall be construed as if not containing the particular unenforceable provision or provisions, and the rights and obligations of the Parties shall be construed and enforced accordingly.

18. **Invalidity.** In the event that this Consent Decree in its entirety is rendered invalid by any court of competent jurisdiction, it will become null and void and may not be used in any manner in any legal proceeding.

19. **Subsequent Rule or Order.** The Parties agree that if any provision of this Consent Decree conflicts with any subsequent Rule or Order adopted by the Commission (except an order specifically intended to revise the terms of this Consent Decree to which CSN does not expressly consent), such provision will be superseded by such Rule or Order.

20. **Successors and Assigns.** CSN agrees that the provisions of this Consent Decree shall be binding on its successors, assigns, and transferees.

21. **Final Settlement.** The Parties agree and acknowledge that this Consent Decree shall constitute a final settlement between the Parties with respect to the Investigation.

22. **Modifications.** This Consent Decree cannot be modified or amended without the advance written consent of all Parties.
23. **Paragraph Headings.** The headings of the paragraphs in this Consent Decree are inserted for convenience only and are not intended to affect the meaning or interpretation of this Consent Decree.
24. **Authorized Representative.** Each Party represents and warrants to the other Party that it has full power and authority to enter into this Consent Decree. Each person signing this Consent Decree on behalf of a Party hereby represents that he or she is fully authorized by the Party to execute this Consent Decree and to bind the Party to its terms and conditions.
25. **Counterparts.** This Consent Decree may be signed in counterpart (including electronically or by facsimile). Each counterpart, when executed and delivered, shall be an original, and all of the counterparts together shall constitute one and the same fully executed instrument.


