ORDER

By the Mobility Division, Wireless Telecommunications Bureau:

- 1. By this Order, the Wireless Telecommunications Bureau (Bureau), Mobility Division, grants an extension of the relief provided by its May 30, 2023 Order (Order), which granted Federated Wireless a conditional emergency waiver of sections 96.67(c)(2) and (3) of the Commission's rules governing the Citizens Broadband Radio Service until June 13, 2023. On June 8, 2023, Federated Wireless (Federated) requested a temporary extension of the relief granted in the Order until the earlier of July 28, 2023, or the restoration of reliable power and backhaul to Federated's impacted systems,² Federated explained that as of June 8, 2023, 50 percent of its ESC sites remained without power and that roughly half of Guam had yet to have power restored.³ Federated indicated that the government of Guam hopes to restore power to the majority of the island within approximately the next month.⁴ Further, Federated stated that backhaul at its ESC sites remains unstable as carriers work to stabilize their operations, which will likely persist until power is fully restored.⁵ Given the continued lack of reliable power and backhaul to Federated's systems affected by Typhoon Mawar, we find that the bases for granting the conditional relief in Order remain equally applicable to the instant request. Accordingly, we find that it is in the public interest to extend the conditional relief granted in the Order until the earlier of July 28, 2023, or the restoration of reliable power and backhaul to Federated's impacted systems. All conditions contained in the Order shall continue to apply to this extension.
- 2. Accordingly, IT IS ORDERED, pursuant to Section 4(i) of the Communications Act of 1934, as amended, 47 U.S.C. § 154(i), and sections 1.3 and 1.925 of the Commission's rules, 47 CFR §§ 1.3, 1.925, that the request filed by Federated Wireless for modification of emergency waiver of sections 96.67(c)(2) and (3) of the Commission's rules, 47 CFR §§ 96.67(c)(2) and (3) is GRANTED to the extent described, and with the conditions specified, herein.
