DOMESTIC SECTION 214 APPLICATION FILED FOR THE ACQUISITION OF CERTAIN ASSETS OF COMMNET WIRELESS, LLC BY ISLAND NETWORK, LLC DBA ROCK ISLAND COMMUNICATIONS

NON-STREAMLINED PLEADING CYCLE ESTABLISHED

By this Public Notice, the Wireline Competition Bureau (Bureau) seeks comment from interested parties on an application filed by Commnet Wireless, LLC (Commnet) and Island Network, LLC dba Rock Island Communications (Rock Island) (together, Applicants), pursuant to section 214(a) of the Communications Act of 1934, as amended, and sections 63.03-04 of the Commission's rules, requesting consent for the acquisition of Commnet's Rural Digital Opportunity Fund (RDOF) support obligations for certain designated census blocks in the state of Washington's Study Area Code 529033 (Assigned Census Blocks) by Rock Island.²

Commnet, a Delaware limited liability company, provides voice and broadband services in portions of the western United States.³ Commnet is an Eligible Telecommunications Carrier (ETC) for the Assigned Census Blocks.⁴ On February 14, 2022, the Bureau authorized Commnet to receive

\$777,601/year over ten years to serve 1,028 census blocks (5,639 locations) in the state of Washington.⁵ Commnet does not provide local exchange service in the Assigned Census Blocks.⁶

Rock Island, a Washington limited liability company, was founded as a wholly-owned for-profit subsidiary of Orcas Power & Light Cooperative (OPALCO), the local non-profit electric cooperative in San Juan County, Washington.⁷ Rock Island provides telecommunications services to approximately 6,500 customers in rural areas of San Juan County, Washington.⁸ Applicants state that neither Rock Island nor OPALCO hold a 10% or greater interest in any other provider of domestic telecommunications services.⁹

Pursuant to the terms of the proposed transaction, Rock Island will acquire the Assigned Census Blocks from Commnet.¹⁰ Applicants state, after consummation of the proposed transaction, Rock Island will undertake deployment of the RDOF-supported network and integrate such activities and operations into its own ongoing operations and its RDOF deployment.¹¹

Applicants assert that the proposed transaction would serve the public interest, convenience, and necessity. Applicants state that "Rock Island has deployed broadband networks and served customers since 2014, in rural areas of Washington, and it is uniquely situated to efficiently deploy RDOF-supported voice and broadband service in the Assigned Census Blocks." According to the Applicants, "Rock Island has the necessary managerial and operational expertise to meet Commnet's RDOF buildout milestones and performance obligations" and that "[a]ll of the Assigned Census Blocks are in the island community of San Juan County, Washington where Rock Island is based and serves its customers." Applicants assert that "[b]ecause Commnet's RDOF areas are adjacent to or nearby Rock Island's existing operations, Rock Island can achieve economies of scale and leverage its labor force, existing infrastructure and operational capabilities to rapidly and cost effectively build out the Assigned Census Block areas as it expands its broadband operations." Applicants state that the "transaction will not result in any adverse alteration to the buildout plans Commnet submitted to the Commission in order to be authorized to receive RDOF funding" and "will not result in any delays in deployment of services consistent with the applicable public interest obligations associated with receipt of RDOF funding." Applicants further state that "Rock Island commits to meeting the buildout

milestones and performance obligations established for the Assigned Census Blocks, including the 40 percent buildout milestone required by December 31, 2025."¹⁷ Applicants also state that Rock Island is not taking on any debt repayment obligations or otherwise increasing substantially its costs to deploy service. ¹⁸ Because Applicants assert that there will be no reduction in competitors in the Assigned Census Blocks, they state there "will be no negative impact on competition in the communications market anywhere in the United States, and the transaction will further facilitate the implementation of the Commission's important RDOF program goals."¹⁹

Because the proposed transaction would involve the exchange and assumption of Universal Service Fund high-cost mechanism obligations, in order to sufficiently analyze whether the proposed transaction would serve the public interest, we accept the Application for non-streamlined processing.²⁰

The proceeding in this Notice shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. Absent such a showing of good cause, any issues not timely raised may be disregarded by the Commission.
