NOTICE OF PROPOSED RULEMAKING

I. INTRODUCTION

1. The Video Division, Media Bureau (Bureau), has before it a petition for rulemaking filed June 7, 2024, by Gray Television Licensee, LLC (Gray), the licensee of WRDW-TV, channel 12, Augusta, Georgia (Station or WRDW-TV).¹ Gray also holds a construction permit to construct a facility on channel 27 at Augusta.² Gray now requests that the Bureau substitute channel 12 for channel 27 at Augusta in the Table of TV Allotments,³ with the technical parameters as set forth in WRDW-TV's current license.⁴

II. BACKGROUND

2. On May 15, 2021, the Bureau granted a petition for rulemaking submitted by Gray to substitute channel 27 for channel 11 at Augusta for WRDW-TV.⁵ On June 25, 2021, Gray was granted a construction permit for its new channel, which is scheduled to expire on June 25, 2024. In its Petition, Gray states that it will be unable to complete construction of the channel 27 facility by the expiration date.⁶ Thus, Gray requests amendment of the Table of TV Allotments to allow it to continue to operate on channel 12. Gray proposes to specify the technical parameters of its currently licensed channel 12 facility.

III. DISCUSSION

3. We believe that the Petitioner's channel substitution proposal for WRDW-TV warrants consideration. WRDW-TV is currently operating on channel 12 and the substitution of channel 12 for channel 27 in the TV Table of Allotments will allow the Station to remain on the air and continue to provide service to viewers within its service area. Given that Gray proposes to utilize its currently

licensed parameters, we believe channel 12 can be substituted for channel 27 at Augusta as proposed, in compliance with the principal community coverage requirements of section 73.618(a) of the Commission's rules (rules),⁷ at coordinates 33-24'-37" N. and 081-50'-36.0" W. In addition, we find that this channel change meets the technical requirements set forth in section 73.622(a) of the rules.⁸

4. We propose to substitute channel 12 for channel 27 for WRDW-TV at Augusta with the following specifications:

IV. PROCEDURAL MATTERS

6. *Showings Required.* Comments are invited on the proposal discussed in this Notice of Proposed Rulemaking (*NPRM*). The Petitioner or any proponent that expresses interest in the allotment will be expected to answer whatever questions are presented in initial comments. The petitioner of a proposed allotment is required to file comments even if it only resubmits or incorporates by reference its former pleadings. The petitioner must restate its present intention to apply for the channel if it is allotted and, if authorized, to build a station promptly.¹⁰ Failure to file may lead to denial of the request. Any requests by a proponent for withdrawal or dismissal of an allotment request must be filed with the Commission in accordance with section 1.420(j) of the rules.¹¹

7. *Cut-off Protection*. The following procedures will govern the consideration of the filings in this proceeding:

(a) Counterproposals advanced in this proceeding itself will be considered, if advanced in initial comments, so that parties may comment on them in reply comments. They will not be considered if advanced in reply comments.¹²

(b) The filing of a counterproposal may lead the Commission to allot a different channel than was requested in the Petition.¹³

8. *Comments and Reply Comments*. Pursuant to sections 1.415, 1.419, and 1.420 of the rules,¹⁴ interested parties may file comments and reply comments on or before the dates indicated on the first page of this document. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).¹⁵

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://apps.fcc.gov/ecfs/</u>. Parties that choose to file electronically only need to submit one copy of each filing so long as the submission conforms to all procedural and filing requirements. Online filing is optional.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission. Any paper filing that is not addressed to the Office of the Secretary will be treated as filed on the day it is received in the Office of the Secretary. Accordingly, failure to follow the specified requirements may result in the treatment of a filing as untimely.

9. *Service*. Pursuant to section 1.420 of the rules,¹⁷ all submissions by parties to this proceeding or by persons acting on behalf of such parties must be made in written comments, reply comments, or other appropriate pleadings. The person filing the comments shall serve comments on the petitioners. Reply comments shall be served on the person(s) who filed comments to which the reply is directed. A certificate of service shall accompany such comments and reply comments.¹⁸ Additionally, a copy of such comments should be served on counsel for petitioner, as follows:

10. *Ex Parte Notices– Restricted.* The proceeding this Notice initiates shall be treated as a "restricted" proceeding in accordance with the Commission's *ex parte* rules.¹⁹ For purposes of this restricted notice and comment rulemaking proceeding, members of the public are advised that no *ex parte* presentations are permitted from the time the Commission adopts a notice of proposed rulemaking until the proceeding has been decided and such decision in the applicable docket is no longer subject to reconsideration by the Commission or review by any court.²⁰ An *ex parte* presentation is not prohibited if specifically requested by the Commission or staff for the clarification or adduction of evidence or resolution of issues in the proceeding.²¹ However, any new written information elicited from such a request or any summary of any new information shall be served by the person making the presentation upon the other parties to the proceeding in a particular docket unless the Commission specifically waives this service requirement.²² Any comment that has not been served on the petitioner constitutes an *ex parte* presentation and shall not be considered in the proceeding. Any reply comment which has not been served on the person(s) who filed the comment, to which the reply is directed, constitutes an *ex parte* presentation and shall not be considered in the proceeding.

11. *Providing Accountability Through Transparency Act.* The Providing Accountability Through Transparency Act requires each agency, in providing notice of a rulemaking, to post online a brief plain-language summary of the proposed rule.²³ Accordingly, the Commission will publish the required summary of this Notice of Proposed Rulemaking on <u>https://www.fcc.gov/proposed-rulemakings</u>.

12. *Availability of Documents*. Comments, reply comments, and *ex parte* submissions will be available for public inspection via ECFS (<u>http://apps.fcc.gov/ecfs/</u>). Documents will be available electronically in ASCII, Microsoft Word, and/or Adobe Acrobat.

13. *Paperwork Reduction and Regulatory Flexibility*. The Commission has determined that the relevant provisions of the Regulatory Flexibility Act of 1980, as amended,²⁴ do not apply to a rulemaking proceeding to amend the Table of TV Allotments, section 73.622(j) of the rules.²⁵ This document does not contain proposed information collection requirements subject to the Paperwork Reduction Act of 1995.²⁶ In addition, therefore, it does not contain any proposed information collection burden "for small business concerns with fewer than 25 employees," pursuant to the Small Business Paperwork Relief Act of 2002.²⁷

V. ORDERING CLAUSES

16. **IT IS ORDERED** that, pursuant to authority found in 47 U.S.C. sections 4(i), 5(c)(1), 303(g) and (r), and 307(b) of the Communications Act of 1934, as amended, 47 U.S.C. §§ 154(i), 155(c)(1), 303(g), (r), and 307(b) and sections 0.61, 0.204(b), and 0.283 of the rules, 47 CFR §§ 0.61, 0.204(b), and 0.283, **IT IS PROPOSED TO AMEND** the Table of TV Allotments, section 73.622(j) of the rules, 47 CFR § 73.622(j), as set forth in this *NPRM*, and this *NPRM* **IS ADOPTED**.

17. **IT IS FURTHER ORDERED** that, pursuant to applicable procedures set forth in sections 1.415, 1.419, 1.420 of the rules, 47 CFR §§ 1.415, 1.419, and 1.420, interested parties may file comments, including counterproposals, on the *NPRM* in MB Docket No. 24-153 and RM-11983 on or before thirty (30) days after publication in the Federal Register and reply comments on or before forty five (45) days after publication in the Federal Register.
