WIRELINE COMPETITION BUREAU ANNOUNCES FINAL ELIGIBLE LOCATIONS FILE AND SUPPORT AMOUNTS FOR ENHANCED ALTERNATIVE CONNECT AMERICA MODEL MECHANISM

WC Docket No. 10-90

By this Public Notice, the Wireline Competition Bureau (Bureau) provides a final list of locations that are eligible for Enhanced Alternative Connect America Cost Model (A-CAM) support, along with a final list of support amounts for Enhanced A-CAM carriers which reflects the updated list of locations. The updated file is available here <https://www.fcc.gov/files/enhanced-acam-final-locations>. Authorization Report 1.3, released today, shows the final support amount and deployment obligations for each Enhanced A-CAM carrier.¹

This final location list incorporates all successful broadband speed and availability challenges that were filed by August 1, 2024,² along with all adjudicated challenges to the broadband fabric, including challenges to unit count totals.³ This list also reflects updated funding commitment data from the current version of the Broadband Funding Map, along with updated location lists to reflect the deduplication process. In all other respects, this file remains unchanged from the interim eligible location list that was released on December 8, 2025.⁴
