**Nature of Service:** Fixed Satellite Service

On February 12, 2025, the Satellite Programs and Policy Division granted special temporary authority to Intelsat License LLC, for an additional period of 180 days, to operate the Horizons 2 satellite at the 73.8° W.L. orbital location with a new platform bias of 0.65° east, 0.4° south and to operate one of its beams over the resulting new coverage area. Horizons 2 provides fixed-satellite service in the 11.7-12.2 GHz (space-to-Earth) and 14.0-14.5 GHz (Earth-to-space) frequency bands. Horizons 2 conducts telemetry, tracking, and command operations using the following center frequencies: 12196.0 MHz, 12198.625 MHz (space-to-Earth); and 14000.5 MHz and 14499.5 MHz (Earth-to-space).
