WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE PUBLIC INTEREST PARTIES' APPLICATION FOR REVIEW OF THE 2025 IPCS WAIVER ORDER

WC Docket Nos. 23-62 and 12-375

Oppositions Due: August 29, 2025

Replies to Oppositions Due: September 15, 2025

By this *Public Notice*, the Wireline Competition Bureau (Bureau) notifies interested parties of the filing deadlines for oppositions, and replies thereto, to an Application for Review filed by the Public Interest Parties.¹ The Public Interest Parties seek review of the Bureau's industry waiver order, which temporarily suspends the compliance deadlines for rules adopted in the 2024 Incarcerated People's Communications Services (IPCS) Order² until April 1, 2027, or any alternative date the Commission sets as part of further action in the IPCS proceeding.³ Oppositions to the Public Interest Parties' Application for Review are due on **August 29, 2025**, and replies to oppositions are due on **September 15, 2025**.

Filing Requirements. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file oppositions and reply to oppositions on or before the dates indicated on the first page of this document. All filings must refer to **WC Docket Nos. 23-62 and 12-375.**⁴

- *Paper Filers*: Parties who choose to file by paper must file an original and one copy of each filing.

- Filings can be sent by hand or messenger delivery, by commercial courier, or by the U.S. Postal Service. All filings must be addressed to the Secretary, Federal Communications Commission.

Permit but Disclose Ex Parte Communications. For the purposes of the Commission's ex parte rules, each petition addressed within this Public Notice will be treated as initiating a permit-but-disclose proceeding under the Commission's rules.⁶ Persons making ex parte presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral ex parte presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during ex parte meetings are deemed to be written ex parte presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written ex parte presentations and memoranda summarizing oral ex parte presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable .pdf). Participants in this proceeding should familiarize themselves with the Commission's ex parte rules.
